- (iii) A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law;
- (iv) A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the copyright owner;
- (v) Information reasonably sufficient to permit Cantaloupe to contact you, such as an address, telephone number, and, electronic mail address; and
- (vi) A physical or electronic signature of a person authorized to act on behalf of the copyright owner.

Notifications of claimed infringement should be sent to the Cantaloupe Copyright Agent at: dmca@cantaloupe.com. For clarity, only DMCA notifications or allegations relating to copyright infringement in connection with user content should go to the Cantaloupe Copyright Agent; any other feedback, comments, requests for technical support, and other communications should be addressed to standard support contacts as identified on the Community site. Cantaloupe will take whatever action, in its sole discretion, that it deems appropriate in response to any notification, including removing the allegedly infringing material from the Community.

Cantaloupe may send any information provided in any notification to the user associated with the allegedly infringing material. If that user sends a DMCA counter-notification, Cantaloupe may forward that DMCA counter-notification to the contact identified in the original notification. Please note that the DMCA provides that any person who knowingly materially misrepresents that material or activity is infringing may be subject to liability.
